## Terms and conditions of permit to keep a declared pest animal for zoo, film or television production

- 1. Maintain the size, type and quality of premises and enclosures in which the declared pest animals are kept as previously approved by the Chief Executive or his or her delegate prior to the issue of this permit.
- 2. Ensure enclosures are of a sufficient standard to prevent escape, theft or release of the declared pest animals and to prevent injury to people, property or other animals.
- 3. Ensure declared pest animals and their enclosures are available for inspection at all reasonable times by an authorised person.
- 4. Produce or make available for inspection this Declared Pest Permit at a reasonable time and place nominated by an authorised person.
- 5. To the extent that no conflict arises with the *Land Protection (Pest and Stock Route Management) Act* 2002, ensure the declared pest animals are kept and cared for in a manner that satisfies the *Animal Care* and *Protection Act* 2001 and any state and national codes of practice for the keeping, transport and care of the declared pest animal.
- 6. Ensure the number of animals held does not exceed the number approved in this Declared Pest Permit. The permit holder must not breed the declared pest animals without first obtaining written permission from the Chief Executive or his or her delegate.
- 7. Subject to permission given in this permit:
  - a) not introduce, feed, keep, release or supply declared pest animals within the State of Queensland;
  - b) ensure any declared pest animals are not sold, supplied to, loaned, hired, exchanged with or otherwise transferred to a person who is not the holder of a current permit;
  - c) keep the declared pest animals on-site in the approved premises and enclosure/s at all times unless:
    - (i) specifically exempted;
    - (ii) moved for veterinary care or on a short-term temporary basis as may be required by the *Animal Care and Protection Act 2001* and any state and national codes of practice for the keeping, transport and care of the declared pest animal;
  - d) ensure the declared pest animals are securely contained and supervised by a responsible person if moved or transported pursuant to condition 7(c)(ii);
  - e) notify the Chief Executive or his or her delegate as soon as practicable:
    - (i) before a sale, supply, loan, hire, exchange or other transfer of any of the declared pest animals;
    - (ii) after theft, escape, release or death of any of the declared pest animals, as the case may be; or
    - (iii) after any increase in the number of declared pest animals as a result of breeding.
- 8. Maintain an escape, theft or release management/contingency plan as previously approved by the Chief Executive or his or her delegate prior to the issue of the permit. In the event of an escape, theft or release of a declared pest animal, the holder of this Declared Pest Permit will activate the plan as soon as possible after the escape, theft or release comes to his or her attention.
- 9. Identify declared pest animals by a tag or other device (e.g. micro-chip).
- 10. a) Keep a register of the declared pest animals which records:
  - (i) the species, number and sex;
  - (ii) any sale, supply, loan, hire, transfer, exchange, theft, escape, release or deaths;
  - (iii) identification numbers on tags or other identification devices; and
  - (iv) any distinguishing marks or features.
  - b) Send a copy of the register to the Chief Executive or his or her delegate within 60 days of receipt of this Declared Pest Permit.
- 11. Obtain and maintain public liability insurance to cover human injury, death or property damage caused by the escape or release of a declared pest animal with a minimum cover of \$10 million or another amount approved by the Chief Executive or his or her delegate.
